## Dog & Cat Permit Application Instructions

The Dog & Cat Permit Rules and Regulations and the Dog & Cat Permit Application are attached to the instruction sheet.

The form is formatted so that you can fill in out on your computer, print it off, and mail it.

Please fill out two (2) copies of the Dog & Cat Permit Application.

When you enter your pet's name, please indicate whether the pet is a dog or cat. Please indicate the breed of the dog or cat [Chihuahua, Siamese, etc.].

Mail both copies of the Dog & Cat Permit Application and your \$25.00 annual non-fundable fee to:

## Dog & Cat Permit Rules and Regulations

All members of TCC are eligible to apply for a "Dog & Cat Permit". There will be a \$25.00 annual non-refundable fee per Dog & Cat permit application. There is a maximum of two dog(s) and/or cat(s) per TCC Member or per TCC Couple.

Dog & Cat Permits are only valid during Maintenance Weekend or Casual Camping when no events are being held.

It will be the decision of a run coordinator if they wish to honor Dog & Cat Permits during an event(s).

An application for a Dog & Cat Permit must be submitted to, and approved by Land Management, prior to the dog(s) and/or cat(s) being allowed on TCC Property.

The following rules must be followed by the pet owner:

- Dog(s) and/or cat(s) must be on a leash when not in a tent, trailer, cabin or carrier. (as long as the pet owner is responsible, consideration will be taken if a dog(s) or cat(s) slips a leash or gets loose).
- If you are staying in a tent, please do not bring your dog(s) and/or cat(s) unless you have a cage that will fit in your tent. If you leave your dog(s) and/or cat(s) in your tent, they must be in the cage. Dog(s) and/or cat(s) must be caged at night if you are in a tent. If you are camping in a tent with dog(s) and/or cat(s) you must place your tent at the top of the hill in the long-term site area.
- Dog(s) and/or cat(s) are not to be left in cars, carriers, or tents when the weather is warm or hot.
- Dog(s) and/or cat(s) are not to be left for extended periods of time chained or tied to a tree, post, etc.
- The owner must pick up after their dog(s) and/or cat(s).
- Nuisance barking will not be tolerated.
- Dog(s) and/or cat(s) are not allowed in the kitchen.
- Dog(s) and/or cat(s) are not allowed in the pool.
- Dog(s) and/or cat(s) are not allowed in the bunkhouse or the TCC trailer.
- If an owner wishes to let their dog(s) and/or cat(s) run free and play, the only area that this can be done in is the parking lot.

- The owner is to be respectful of others at the landsite and is to ask permission to bring their dog(s) and/or cat(s) onto other member's sites.

Failure to follow these rules will result in a \$25.00 fine for each violation. Failure to pay a fine within 90 days or after three violations the Dog & Cat Permit will be revoked.

Failure to abide by this Dog & Cat Permit Policy will result in Land Management making a report to the TCC Membership at the next quarterly meeting. At this time any TCC member may recommend a vote that the violator's TCC Privileges (use of the landsite) be suspended for a specified period of time or be permanently revoked.
